Introduction

The Research Continuity Scheme provides funding for Academic staff to maintain research activities that are critical for the execution of a future funding application. The funds are primarily expected to support the activities of early- and mid-career researchers.

Funding can only be requested if it is necessary to maintain the research capacity that underpins a significant future funding application, so that the proposed research can be prosecuted if the grant is successful. Examples of activities that are necessary to maintain research capacity might include the maintenance of animal colonies, or time-series collection of field or experimental data where a break in collection would result in loss of past research. This loss of research capability is distinct from a delay in research outcomes.

Applicant Eligibility

Applicants must:

- be a lead CI (Chief Investigator) on an unsuccessful significant (full proposal) funding opportunity in the last 4 months.
- be on a fixed-term (with at least one year remaining on your contract) or continuing contract within the Faculty of Science.
- have no other funding available (at the time of submission).
- have a clear pathway to being a lead CI on a significant funding application within the next 12 months which lists the University of Melbourne as the Administering Organisation.
- have endorsement and confirmation of School funding from their Head of School.
- not have received continuity funding within the last 5 years.

Due to limited funding, priority will be given to level A-C staff.

An applicant can only apply a maximum of once every two years.

Funding

Successful applicants will receive a maximum total amount of \$50,000, funded on a 1:1 basis between the School and the Faculty, i.e. a maximum of \$25,000 Faculty funding which must be matched by equivalent School funding, with a total of \$100k Faculty funding available for this Scheme.

Funds must be spent within one year, and no part of the funds can be used towards the CI's salary.

Applicants should base the level of funding on their project requirements. Carefully consider the expenditure required to maintain your research activity until the outcome of your next funding opportunity.

Application Process

- Complete the online request form to explain the potential loss of your research capability and provide a succinct budget.
- Your eligibility will be reviewed by the Science Research Office.
- Requests will be assessed and endorsed by the Associate Dean Research (or approved delegate).

Evaluation and Assessment

The assessment criteria focus on the researcher's capacity to gain significant future funding for their research.

- Potential of funding to enhance applicant's competitiveness for future funding [50%]
- Track record of researcher, relative to opportunity. [50%]

Timeline

3 rounds with closing dates in mid-February, mid-June, mid-October.
